- Chairman Gene Leifeld called the meeting to order at 1700 hours

- Discussion on Social Host Ordinance. Stacy informed that she has emailed copies of the Goodhue County Social Host Ordinance and the City of Goodhue ordinance to City of Zumbrota Administrator Neil Jensen. The Seller/Server ordinance was not approved.
- The CHI Town Hall presentation was reviewed by board members'. Stacy handed out copies of the agenda for Wednesday evening October 12, 2011. Stacy went through the presentation covering the binge drinking, information on marijuana use, and tobacco trends and usage for students, and perceived risks of harm in Zumbrota-Mazeppa.
